#### **STATE OF THE COUNTY REPORT**

Thomas M. Nelson, County Executive for Outagamie County is responsible for: Coordinating and directing the administrative and management functions of the county government; Appointing and supervising county department heads; and Appointing the members of boards and commissions. In Outagamie County, there are 36 agencies, departments and offices headed by various elected or appointed officials. The county executive appoints 15 department heads whose appointments are confirmed by the county board of supervisors. There are 20 boards and commissions to which the county executive appoints members. Section 59.17(5) of the Statutes requires the county executive to, "...annually, and otherwise as may be necessary, communicate to the board the condition of the county, and shall recommend such matters to the board for its consideration as he or she considers expedient. Notwithstanding any other provision of the law, he or she shall be responsible for the submission of the annual budget to the board and may exercise the power to veto any increases or decreases in the budget..." In other words, the county executive is required to submit to the county board of supervisors an annual state-of-the-county message, recommendations regarding issues of concern, and a proposed annual budget. County Executive, Tom Nelson reported to the club that it was important to acknowledge the department heads, constitutional officers and county board supervisors for their assistance with crafting the budget. The budget features a declining tax rate by .63%, minimizes the impact to the average home owner (1.01%) to less than the year-to-date rate of inflation (1.6%). It holds overall health insurance adjustments to 2%, well below the industry average, and transitions to a self-funded health insurance model to leverage substantial savings in future budgets. Tom also reported to the club about 3 service areas in our county. First being the Airport: The airport has done really well in the past few years. As you most recently are aware of they have changed their name to the Appleton International Airport. They are looking to have Gulfstream expand in the next few years as well as 2 new facilities and to relocate the tower. The airport had \$400 million in economic output, which is more than the Green Bay Packers. Second being Criminal Justice reform. He touched on a new initiative called the Evidence based decision making initiative. Research shows implementing evidence based decision making can reduce recidivism up to 30% and a cost/benefit of \$10,000 per offender can be realized. They are working with 5 other counties and 2 other states. Lastly the Recycling Center. Our Recycling center is one of the largest facilities in the country processing over 94-95 tons this past year and looking to increase that number to 100. Brown, Outagamie and Winnebago Counties (commonly called the BOW) signed an agreement in 2007 to develop a single-stream recycling facility for operation over 15 years. These three counties have enjoyed a partnership that has created landfill and recycling efficiencies for the benefit of all residents.
